Chapters Health System Expands Resources to Provide Home Care in Seven Counties

Finalized Purchase Agreement of Achieve Home Care, LLC

TAMPA, FL (January 8, 2019): Chapters Health System (Chapters Health) announced the signing of a finalized purchase agreement for Achieve Home Care, LLC (Achieve), which expands its resources to provide home care in seven counties. Chapters Health is a not-for-profit organization headquartered in Temple Terrace, with current affiliates that include HPH Home Health in Pasco and Pinellas counties; Chapters Health Palliative Care in Hillsborough, Highlands and Polk counties; Good Shepherd Hospice in Polk, Highlands and Hardee counties; HPH Hospice in Pasco, Hernando and Citrus counties and LifePath Hospice in Hillsborough County. Achieve currently serves patients in Hillsborough and Polk counties, but is also licensed to provide home care in Highlands, Hardee and Manatee counties. The integration of Achieve staff and patients will occur over the next three months to ensure continuity of care.

“Our purchase of Achieve is designed to provide opportunities that allow both organizations to function more efficiently in today’s healthcare world,” said Andrew Molosky, MBA, FACHE, CHPCA, president and chief executive officer at Chapters Health. “We will continue to provide the medical expertise and compassionate care that both our organizations are known for and at the same time, expand access to quality healthcare for a greater numbers of individuals in our communities who are faced with post-operative recovery as well as those with complex medical conditions and end-of-life issues.”

“I am confident that our common mission will guarantee that more patients have opportunities to access quality home care,” said Dr. Tammy King, owner of Achieve.

This agreement advances the shared goals of:

- Expanding the Chapters Health network of home care services across five additional Florida counties with commitment to quality, service and access.
